To present an opportunity for all people to share and experience cultural traditions by celebrating the oneness in the community through a diversity of music, arts and food.

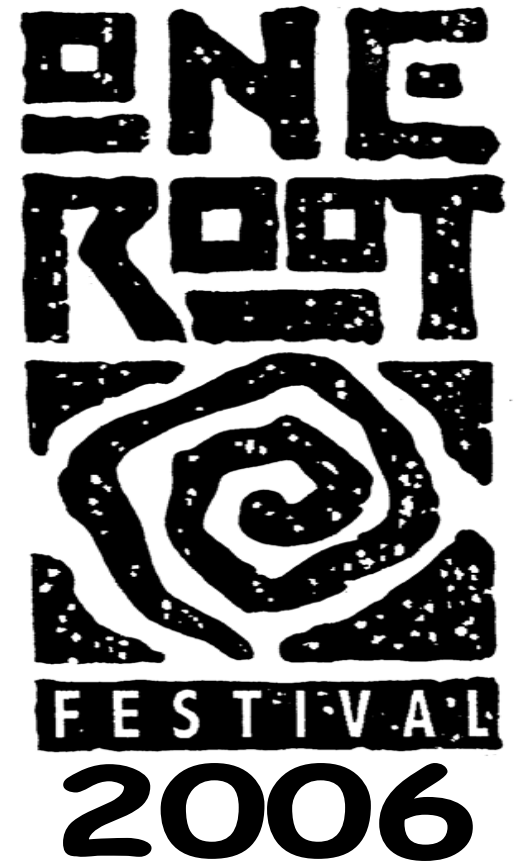
## ONE ROOT VISION:

The interaction between volunteers, vendors, performing artists and attending public, provides many opportunities for sharing of family and cultural traditions. The environment is clean, safe, non-threatening, and cheerful. Though One Root Festival is located in Roseville, its draw is regional. Working closely within the network of local and regional agencies and groups, businesses and the media, the festival builds volunteer and sponsorship support.

To be included in the event program, all applications must be received by September 1, 2006.

This contract is made by and between the below-signed exhibitor and the (Presenter) of the One Root Festival event.

The rental period is two (2) hours before the advertised event time to allow for vendor setup, and one (1) hour after event closes for cleanup.

The exhibitor agrees to set up their property at least one (1) hour before the event opens, and remove the same an hour after the event closes on Sunday.

The exhibitor agrees to have the exhibit open and ready for transaction of business on the hour that the show is scheduled to open to the public, and keep it in a continuous uninterrupted operation until the closing hour of the event.

Exhibitor agrees to unload and remove his/her vehicle as quickly as possible prior to arranging his/her booth. Exhibitor further agrees to obey all traffic laws and to avoid causing congestion with his/her vehicle or possessions. .

The exhibitor at his/her cost will supply all equipment, showcases and displays. .

**Booth staffing and maintenance:** At all times during the One Root Festival event, the exhibitor shall keep his/her rental area staffed with adequate attendants and will confine the display of his/her merchandise to his/her area contracted herein. The display area and areas visible to the public will be well-maintained and free of trash, debris, etc.

The exhibitor shall comply with and instruct his/her staff, employees, and agents to comply with the Vendor Policies and requirements of the vendor space rental agreement.

**Taxes, licenses and charges:** All sales taxes, use taxes, excise taxes and other taxes and governmental charges imposed by the Federal, state, or local government unit shall be reported and paid by the exhibitor who shall have responsibility for the same.

**Laws, rules and regulations:** The exhibitor agrees to abide by, obey and help enforce any law, rule or regulation promulgated by any governmental unit pertaining to the operation of the ONE ROOT FESTIVAL EVENT licensing and use of the premises. Workers compensation, unemployment compensation where applicable, shall be provided and paid by the exhibitor. The exhibitor agrees to comply with all City and State codes and ordinances.

**Liability:** It shall be the responsibility of the exhibitor to obtain at his/her expense, liability, fire and theft insurance to protect his/her self, his/her employees, his/her customers and his/her merchandise, equipment and appliances.

**Food Vendors:** Must have completed the Risk Assessment Form provided by the One Root Festival Food Event Coordinator in order to obtain a Health Certificate from the Placer County Health Department.

**Beverages:** *ALL BEVERAGES WILL ONLY BE SOLD BY THE ONE ROOT FESTIVAL no exceptions. This is a non-alcohol, drug and tobacco free event.*

**I, the undersigned, hereby agree and shall defend, indemnify and hold harmless all One Root Festival producers, presenters, partners and sponsors including but not limited to: Dunia United Congress, a non-profit organization, and The City of Roseville, and their sponsors, officers, agents, employees, or volunteers, and/or members of the One Root Festival Committee, from any liability for damage or claims for damage of property and/or personal injury, including death, which may arise from or be in any way connected with my participation in The One Root Festival.**
